

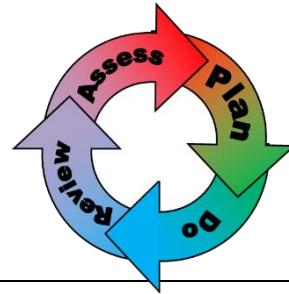


Children who have been identified as requiring SEN support will be reviewed termly, this will be with the class teacher and parents/carers and in the summer term, with their next teacher. The SENCO will be in attendance if requested by either party. It is important that school and home work closely together towards outcomes so that pupils receive the most appropriate intervention and support to ensure progress is being made and achievements celebrated.

At the review meeting for children identified with a special need and/or difficulty, the additional provision that has been made for the pupil will be discussed in terms of its effectiveness, whether outcomes have been achieved and if progress has been made. New targets will be set or adjusted to meet the needs of the child and ensure progress is continued. Pupils are encouraged to express their views regarding their learning with their class teacher, their parent/carer or within the review meeting.
